Town Board Meeting

The July 20, 2020, Sugar Creek Town Board Meeting was called to order at 6:30 p.m., at the town hall, by Chairman, Dale Wuttke.

There were 15 visitors present.

All open meeting laws have been complied with for this meeting.

All the Town Board Members were present: Chairman-Wuttke, Supervisor - Robers and Clarbour, Clerk-Boyd and Treasurer-Loveless. Also present was Attorney, Steve Koch.

The minutes from the June 15, 2020 Town Board Meeting and the June 18, 2020 Special Town Board Meeting were approved as presented. Motion made by David Robers and seconded by Clarbour; motion carried unanimously.

The Treasurer's Report was reviewed with \$1,016,937.98 in cash assets as of 07-18-20.

Fire Chief's Report. The Chief was present. He was here about the referendum question.

The road report was present by Greg Walbrandt. Scott's Construction started road work today. Greg has been cleaning up after storms. The Board discussed the speed limit on Hazel Ridge Road and the line of sight at the intersection of Kennel Road and Hazel Ridge Road. Greg will bring estimates next month for new loader tires.

Certified survey map review request from Loren Johnson and David Johnson. The CSM is a farm separation creating 1 single family lot, approx. 4.43 acres. Tax parcel # GSC 2100005, property located at W6256 Sugar Creek Road. The Plan Commission recommended approval. David Robers made a motion to approve the above stated CSM for farm separation; Clarbour seconded; motion carried unanimously.

Introduction of Michele Jacobs candidate for Register of Deeds. Michele introduced herself and gave a brief history of her work experience.

Water/flooding problem around Silver Lake. Dale Wuttke explained the process for Lake Wandawega. Dale explained that Lake Wandawega is going down. He felt that Silver Lake has also gone down some as well. For now it was decided to continue to pump Lake Wandawega and see what happens to Silver Lake. This item will be placed on the next Town Board agenda.

Unsanitary debris complaints. Jason Rowland is doing a great job dealing with complaints. There are two properties in Silver Lake that need to be sent notices. David Robers made a motion to have Attorney, Steve Koch send notices to the two properties (W5601 Lake Shore Dr and N6585 Forest Road) in Silver Lake to get them cleaned up; Clarbour seconded; motion carried unanimously.

Referendum question for Fire Dept. for Nov. general election, Resolution 2020-5 Resolution of Town Board Exercising Referendum Option. Dale Wuttke made a motion to approve Resolution 2020-5 subject to levy numbers added after they become available for the Dept. of Revenue, and subject to final approval from the Town Attorney, Steve Koch; Robers seconded; motion carried unanimously.

Sale of old truck. Greg would like to wait till Sept. Trucks currently on Wisconsin Surplus are only going for \$4,000-6,000. He thinks that we will get a better price when we get closed to fall/winter.

Preparations for elections for 2020. Greg will be making sneeze guards for the elections. Clerk was concerned that we should have a contingency plan for elections if the Clerk would get sick. No action taken.

Operator's license. David Robers made a motion to deny the operator's license from Ryan Serrato because it was not complete and of his records; Wuttke seconded; motion carried

unanimously.


