There were 1 visitor present.

The Treasurer's Report was reviewed with \$1,486,761.57 in cash assets as of 03-15-21. There are still 2 outstanding personal property taxes.

Fire Chief's Report. None

The road report was presented by Greg Walbrandt. They have been working on cold patch, snow fence, chipping and sign repairs. The temporary weight limits are on. White Construction, contracted by TDS has damaged two spots that need to be repaired. David Robers made a motion to get bid for repairs and charge the contractor to repair the two spots that they have damaged; Clarbour seconded; motion carried unanimously.

Purchase of a new computer for Town. Last month \$1,200 was approved to replace Greg's computer. Kalt Consulting has recommended replacing the office computer, giving the office computer to Greg and setting up a mini server for Sharri and Diane to use Quickbooks. David Robers made a motion to approve the purchase of computers not to exceed \$2,000; Clarbour seconded; motion carried unanimously.

Repairs/replacement of Town tractor. The current tractor needs to have the brakes repaired approx. \$4,000 and the air seat is not working. Greg has looked into a 100 horse powered tractor with front wheel assist, approx. \$59,000 municipal price with a \$6,000 to \$8,000 trade-in. David Robers made a motion to get prices and bring back to next months meeting; Clarbour seconded; motion carried unanimously.

Road bids for 2021. This year will be north Wandawega, Lauderdale Lakes Estates, south Wandawega, Gilbert and Avatavia. Put bids out for opening and letting next month.

Unsightly debris complaints at N6585 Forest Road. There has been not changes to the property since last month. The new police liaison will contact the property owner.

Operator's license. Attorney, Steve Koch recommended denying the operator's license for Joseph A. Schwarz. David Clarbour made a motion to deny the license for Joseph A. Schwarz; Robers seconded; motion carried unanimously.

Public comment. None.

Clerk's report. Talked about open book and Board of Review.

Closed session the Town Board will meet in closed session pursuant to section 19.85 (1)(g) conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved. No closed session. No action taken.

Bills. David Clarbour made a motion to pay the bills as listed by the Clerk; Robers seconded; motion carried unanimously.
