Town Board Meeting

The June 21, 2021, Sugar Creek Town Board Meeting was called to order at 6:30 p.m., at the town hall, by Chairman, Dale Wuttke.

There were 3 visitors present.

All open meeting laws have been complied with for this meeting.

All of the Town Board Members were present: Chairman-Wuttke, Supervisor - Robers and Clarbour, Clerk-Boyd and Treasurer-Loveless. Also present was Attorney, Steve Koch.

The minutes from the May 17, 2021 Town Board Meeting were approved as printed. Motion made by David Robers and seconded by Clarbour; motion carried unanimously.

The Treasurer's Report was reviewed with \$1,219,337.32 in cash assets as of 06-20-21. All personal property taxes have been paid.

Fire Chief's Report. No Chief present. Later in the agenda will discuss Fire Agreement.

The road report was given by Greg Walbrandt. The gas pipeline will be fixing the roads that they damaged.

Certified survey map request from Taylor Road Farms, LLC. The CSM is for one single family lot, approx. 3.169 acres. The property is located at W6877 Taylor Road, part of tax parcel # GSC 1700004. The Plan Commission recommended approval. David Robers made a motion to approve the above stated CSM; Clarbour seconded; motion carried unanimously.

Request for a road modification from Gene F. Shilts. Tax parcels GI 00278A and GI 00278, Knoll Road. The Plan Commission recommended approval. David Robers made a motion to approve the road modification in the current 2021 condition with the current property owners creating a maintenance agreement for maintenance of the road; Clarbour seconded; motion carried unanimously.

Bids for damage to roads by White Construction. David Robers made a motion to accept the offer from TDS (not to exceed \$10,000 for road repairs for damage to road during construction) for damage to two roads; Clarbour seconded; motion carried unanimously.

Dog licencing/complaints for: 1.) Tyler and Jennifer Bidlack; and 2.) N. Raquel Bonilla Gonzales and Guillermo Huerta. Bidlack's have paid the fee but need to provide information for the licencing. Gonzales/Huerta have not responded. The Sheriff's Dept. liaison will look into the matter.

Elkhorn Area Fire Department Service Agreement. Town of Geneva wanted to change the boundaries to take the high traffic areas out of the EAFD. Dale Wuttke made a motion to approve the current Service Agreement as is with not changes; Robers seconded; motion carried unanimously.

Alcohol beverage and cigarette license applications. David Robers made a motion to approve all the license except for Operator's licenses for McQuality and Doman; Clarbour seconded; motion carried unanimously. David Robers made a motion to deny the Operator's License for Angeline Doman; Clarbour seconded; motion carried unanimously. David Robers made a motion to table the Operator's License request from Steve McQuality till the outcome of his court case; Clarbour seconded; motion carried unanimously.
