

The June 20, 2022, Sugar Creek Town Board Meeting was called to order at 6:30 p.m., at the town hall, by Chairman, Dale Wuttke.

There were 9 visitors present.

All open meeting laws have been complied with for this meeting.

All of the Town Board Members were present: Chairman-Wuttke, Supervisor - Robers and Clarbours, Clerk-Boyd and Treasurer-Loveless. Also present was Attorney, Steve Koch.

The minutes from the May 16, 2022 Town Board Meeting and the May 23, 2022 Special Town Board Meeting minutes were approved as printed. Motion made by David Robers and seconded by Clarbours; motion carried unanimously.

The Treasurer's Report was reviewed with \$1,533,613.97 in cash assets 06-20-22.

Fire Chief's Report. None.

The road report. Scott's has completed the warranty work and also did Schmidt and Sugar Creek Road. The first mowing of ditches is almost complete. They have mowed the cemetery and worked on brush cutting.

Randy Licht to talk about ATV/UTV use on town roads. Representatives gave a presentation on ATV/UTV use on town roads. They provided an Ordinance and an ATV/UTV Road Use Concerns to the Town Board. David Robers made a motion to table this item to get more information and direction from Walworth County; Wuttke seconded; motion carried unanimously.

2021 Annual Report presented by Art Tillamn-Sitzberger. The representative from Sitzberger was not available to make the presentation.

Millard Cemetery, mowing, lot line adjustment and financial. Greg has mowed the cemetery. We do not have a legal description for the exchange property. David Robers made a motion to take all means necessary by Steve Koch to exchange the property and look into the financial situation for the cemetery; Clarbours seconded; motion carried unanimously.

Unsightly debris at N5379 County Road H. Mr. Bruemeister was served. Dale Wuttke has talked with him, thanked him for cleaning the property. Mr. Bruemeister claimed that he never received the notice from Feb. Dale talked with him in April about cleaning the property. He should be fined from May 16th to June 10th, approx. \$1,400.00 in fines and out of pocket costs for fees and filing and serving fees. David Robers made a motion to have Attorney Koch and Dale work out a payment plan with all costs and fines included, if any payments are missed the full amount will be placed on the tax bill as a special charge; Clarbours seconded; motion carried unanimously.

ARPA grant money budget, proposals for air conditioning in the town hall and wood chipper. David Robers made a motion to approve the proposal from Southern Lakes Plumbing and Heating Inc. For \$9,775.00 with the I-Wave purifier; Wuttke seconded; motion carried unanimously. David Robers made a motion to purchase Bandit wood chipper with trade of the old equipment for \$40,926.00; Clarbours seconded; motion carried unanimously.

Operator's License. Done above.


