

The Sept. 19, 2022, Sugar Creek Town Board Meeting was called to order at 6:30 p.m., at the town hall, by Chairman, Dale Wuttke.

There were 4 visitors present.

All open meeting laws have been complied with for this meeting.

The following Town Board Members were present: Chairman-Wuttke, Supervisor - Robers and Clarbour and Clerk-Boyd. Absent was Treasurer-Loveless. Also present was Attorney, Steve Koch.

The minutes from the Aug. 15, 2022 Town Board Meeting minutes were approved as printed. Motion made by David Robers and seconded by Clarbour; motion carried unanimously.

The Treasurer's Report was reviewed with \$1,777,694.20 in cash assets 09-18-22.

Fire Chief's Report. Rod Smith was present. The Amendment to the contract will be on the Oct. Town Board Meeting.

The road report. The road report was given by Greg Walbrandt. Scott's has completed the road work for this year. They have been shouldering roads, crack filling brush cutting mowing the Millard Cemetery and getting trucks ready for fall and winter.

Amended conditional use permit request from Benjamin J. Buser. The amended conditional use request is for two signs, one free standing and one mounted to the building. Tax parcel # GSC 2400003, property located along Schmidt Road. The Plan Commission recommended approval. David Robers made a motion to approve the above stated amended conditional use permit; Clarbour seconded; motion carried unanimously.

Unightly debris at N5379 County Road H. Steve Koch informed the Town Board that we were giving default judgement on Sept. 9th for all cost involved. Mr. Burmeister was present for the court appearance. This item will be back in court in November. The property will be monitored for compliance till the November date.

Weight Limit on Town roads. Steve Koch informed the Town Board that the Town has an Ordinance that will allow for Class B roads. Greg has 6 roads he would like to install signs on to stop large trucks from cutting across on.

Loan for Ambulance. The 2022 budget calls for a loan for the ambulance of \$61,000. The loan for the \$61,000 for the ambulance to be paid back in one payment next year, not a line of credit.

An Ordinance To Require Waterfront Placement Of Address Signs. The Town Board discussed the ordinance from LaGrange. The Clerk will prepare the ordinance and bring it back for the Oct. Town Board Meeting.

Resolution 2022-01 To Amend the 2022 Budget. David Robers made a motion to approve Resolution 2022-01 To Amend the 2022 Budget; Wuttke seconded; motion carried unanimously.

Health insurance enrollment and changes. This item will be placed on the Oct. Town Board Agenda.

Operator's License. None

Public comment. Discussed the Lauderdale Lakes Management District working with the Town on the Plantation Road reconstruction due to the water shed study.
