Special Town Meeting

The November 14, 2022 Sugar Creek Special Town Meeting was call to order at 5:40 p.m., immediately following the Public Hearing, at the town hall by Chairman, Dale Wuttke.

There were 0 visitors present.

All Town Board Members were present (Chair-Wuttke, Supervisors- Robers and Clarbour, Clerk-Boyd and Treas.-Loveless).

All open meetings laws have been complied with for this meeting.

To approve the total 2023 highway expenditures, pursuant to Section 81.01 (3) of Wisconsin Statutes. Diane Boyd made a motion to approve the 2023 highway expenditure of \$1,079,030.94; Dale Wuttke seconded. A vote was taken: yes-5, no-0 and abstain-0. Motion carried.

Fix the compensation of elected town officers, pursuant to Section 60.32 of Wisconsin Statues. David Clarbour made a motion for compensation to remain the same for Chairman and Supervisors (Chairman-\$4,000/year, .585/mile for mileage and \$62/meeting attended and Supervisor's-\$2,000/year, .585/mile for mileage and \$50/meeting attended); Robers seconded. A vote was taken: yes-5, no-0 and abstain-0. Motion carried. David Robers made a motion to fix the Treasurer's salary at \$12,800/year, .585/mile for mileage and \$50/meeting attended; Clarbour seconded. A vote was taken: yes-5, no-0 and abstain-0. Motion carried. David Robers made a motion to fix the Clerk's salary at \$44,000/year, .585/mile for mileage, \$50/meeting attended and either a stipend of \$9,000 per year for health insurance paid monthly or participation in the state health insurance with a copay of \$300/month by clerk; Clarbour seconded. A vote was taken: yes-5, no-0 and abstain-0. Motion carried.

David Robers made a motion to authorize the Town to levy \$796,195.52; David Clarbour seconded. A vote was taken: yes-5, no-0 and abstain-0. Motion carried.

Dale Wuttke made a motion to adjourn; David Robers seconded; motion carried unanimously.

There were 0 visitors present.


All open meetings laws have been complied with for this meeting.
