**RESOLUTION ACCEPTING THE TRANSFER OF THE REAL ESTATE, FUNDS
AND PERSONAL PROPERTY OF THE MILLARD CEMETERY**

WHEREAS, the Millard Cemetery is a cemetery located in the Town of Sugar Creek located along County Trunk Road O, Elkhorn, Wisconsin 53121, and legally described as follows:

“A part of the Northwest 1/4 of Section 9, Town 3 North, Range 16 East, described as follows: Commencing in the center of the road leading from the United States road to Heart Prairie North 11° West from said United States road where formerly stood the quarter stake between Section 8 and 9 of Town 3 North, Range 16 East, 18 Chains 55 Links, the corner stake stands North 79° East, 50 links from the true corner; thence North 79° East, 5 Chains; thence North 11° West, 4 Chains 45 Links; thence South 79° West, 5 Chains to the center of the road; thence along the center of the road South 11° East, 4 Chains 45 Links to the place of beginning. Said land being in the Town of Sugar Creek, County of Walworth, State of Wisconsin.”

WHEREAS, the Millard Cemetery was controlled, managed and operated by Mr. Allen Craig Guthrie; and

WHEREAS, Mr. Allen Craig Guthrie passed away on or about September 18, 2021; and

WHEREAS, the children of Allen Craig Guthrie do not wish to manage, control and take care of the Millard Cemetery; and

WHEREAS, Wis. Stat. § 157.07 obligates a town to take over the management and control of a cemetery when it has been abandoned; and

WHEREAS, as there are no individuals who are able to maintain, control and take care of the Millard Cemetery,

NOW, THEREFORE BE IT HEREBY RESOLVED:


1. That the Town of Sugar Creek hereby accepts by transfer the real estate legally described as follows:

"A part of the Northwest 1/4 of Section 9, Town 3 North, Range 16 East, described as follows: Commencing in the center of the road leading from the United States road to Heart Prairie North 11° West from said United States road where formerly stood the quarter stake between Section 8 and 9 of Town 3 North, Range 16 East, 18 Chains 55 Links, the corner stake stands North 79° East, 50 links from the true corner; thence North 79° East, 5 Chains; thence North 11° West, 4 Chains 45 Links; thence South 79° West, 5 Chains to the center of the road; thence along the center of the road South 11° East, 4 Chains 45 Links to the place of beginning. Said land being in the Town of Sugar Creek, County of Walworth, State of Wisconsin."

, any and all funds in bank accounts regarding or relating to the Millard Cemetery, and any and all personal property regarding or relating to the Millard Cemetery.
