## Town Board Meeting September 18, 2023, Minutes

The September 18, 2023, Sugar Creek Town Board meeting was called to Order at 6:30p.m., at town hall, by Chairman David Robers.

All open meeting laws have been complied with for this meeting.

Present were Chairman - David Robers, Supervisor 1 - Jamie Morin, Clerk - Roxanne Johnson and Treasurer - Sharri Loveless.

The minutes from the August 21, 2023 Town Board Meeting were approved as printed. Motion to approve made by David Robers and seconded by Jamie Morin; Motion carried unanimously.

The Treasurer's Report was reviewed with \$1,507,773.14 in cash assets and \$79,903.30 in checking as of 09-18-23. Chris Baxter and Eric Stoll from Advia Credit Union spoke about the data breach affected by the MOVEit software. Advised that the Town of Sugar Creek is given a 1-year free membership in Experian Business Credit Advantage, must enroll by November 30, 2023.

Fire Chief's Report. None.

The Road Report. Greg advised the ATV/UTV signs have been placed. The 45mph signs on Cobbie Road have also been placed. Roadside ditch cutting is being done and trucks are going in for maintenance. Olcott Exteriors has installed the gutters on Town Hall.

Lake Wandawega. John Consolino gave a presentation on Lake Wandawega forming a Lake District. They would like Town of Sugar Creek to also be a member of the Lake District. John will email Attorney Steve Koch the documents and Attorney Steve Koch will be reviewing the documents.

Stop signs on Poplar and Kenosha Drive. Greg would like to put a stop sign on opposite of road, along with stop ahead signs with red flags warning of new stop signs. Greg will see if he can shave the Arborvitae enough that the sign can be seen. Greg will be working on this and see what options would be best for the safety and welfare of the community.

Unsightly debris. N5379 County Road H, tabled until October 2023 meeting.

Operator License. David Robers made a Motion to approve Scott Johnson, Bonnie J. Contreras and Morgan Daniels licenses, Jamie Morin seconded the Motion; Motion carried unanimously.

Public comment. Jerry Lubick concern about getting into and out of the current facility for yard waste. Would like to see the Town of Sugar Creek possibly get their own compost site. Kathy Kostock inquired about seasonal speed bumps on Oriole and Oak. Dale Grundmann would like speed survey done on Briggs Road. John Settler would like to see a Burning Ordinance put in place, due to problems with the neighbors causing property damage due to a very large bonfire. New home on Laurel with junk vehicles and temporary driveway.

Approval of bills. David Robers made a Motion to approve all bills as presented, Jamie Morin seconded the Motion; Motion carried unanimously.
