# Ordinance Rescinding ATV/UTV Ordinance and Adopting the County Ordinance

WHEREAS, on or about the 2\ day of \(\frac{1000}{1000}\), 2025, the Town of Sugar Creek adopted Ordinance No. \(\frac{20250}{1000}\), regarding the usage of ATVs and UTVs on Town roads; and

WHEREAS, the Town does not have any law enforcement employees to enforce that ordinance; and

WHEREAS, the Town wishes to have the County of Walworth Sheriff's Department enforce its ATV and UTV Ordinance; and

WHEREAS, the Town believes that if it adopts the Walworth County Ordinance, the Walworth County Sheriff's Department will enforce the Town ATV/UTV Ordinance,

NOW, THEREFORE, be it hereby ordained by the Town Board of the Town of Sugar Creek:

### SECTION L

An Ordinance No. 2025-0 for ATV and UTV regulation is hereby rescinded;

## SECTION II. State laws adopted by reference.
